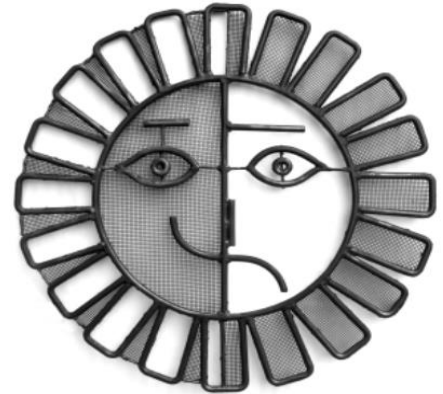

The new fees are shown below:

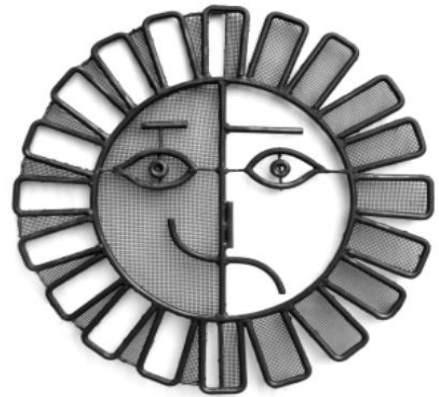
